- The LGBTQ/HIV Project provides advice and direct legal representation to members of the LGBTQ+ community and people living with HIV/AIDS in a wide range of civil practice areas, including public benefits, anti-discrimination, housing, family law, and access to medical care.

Interns will assist with activities such as: conducting client interviews, investigating cases, appearing in court and administrative proceedings with attorneys, legal research, and writing memoranda of law. Interns may also work closely with community partners and provide Know Your Rights clinics, workshops, and legal education programs.
