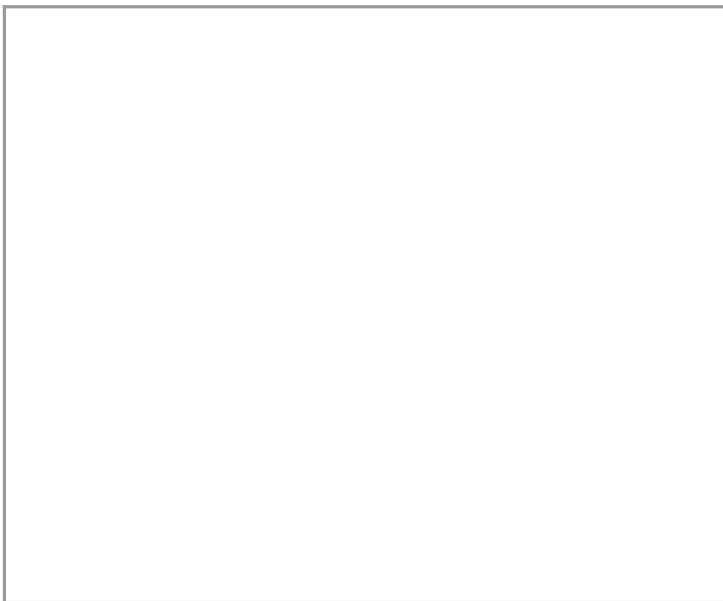

## Our Honorees



**Debo P. Adegbile** is a partner at the law firm Wilmer Cutler Pickering Hale and Dorr LLP (WilmerHale). His practice focusses on a broad range of matters at the intersection of law, business, and government policy.
