

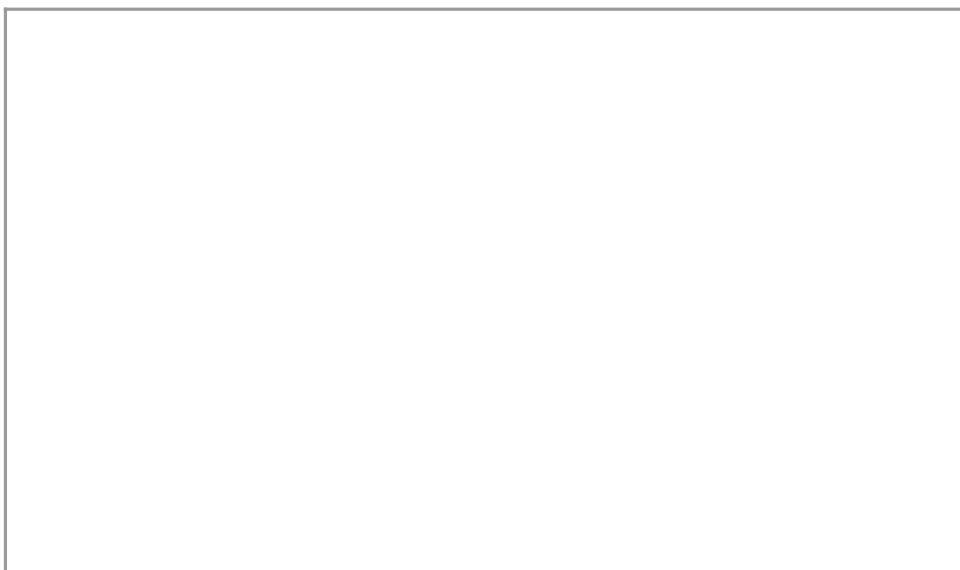

Celebrating Our 50th Anniversary

Our mission is to fight poverty and seek racial, social, and economic justice for low income New Yorkers. Since 1968 our advocates have been at the forefront of the fight for justice for New Yorkers living in poverty. We have been responsible for *Golberg v. Kelly* and increasing the incomes of hundreds of thousands of New York City families; for the kneeling buses and Access-A-Ride that provide transportation for people with disabilities; for the reduction of lead paint and lead poisoning across the city; for the preservation of tens of thousands of affordable apartments and houses; for the safety of thousands of survivors of domestic violence; for unifying and stabilizing immigrant families; and for providing access to a high quality education for children with special needs.
