University of Pennsylvania Law School and a B.A. in Political Science from Spelman College.

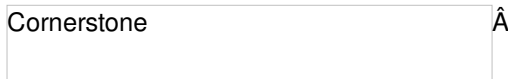

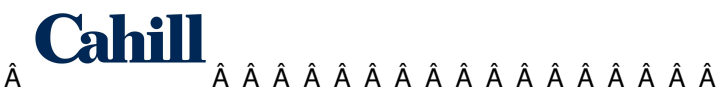
