Shelley J. Dropkin is the Deputy Corporate Secretary and General Counsel, Corporate Governance, and a Managing Director of Citigroup Inc. She also serves as General Counsel of the Citi Foundation. Ms. Dropkin has been with Citigroup since 1993 during which time she also served as Assistant General Counsel and Senior Counsel. Prior to joining Citigroup (then Primerica Corporation), Ms. Dropkin was an Associate at Winston & Strawn.
